bTd Travel & Jets Expands to Spain and the GCC After Seed-2 Funding, Launches Al Concierge with Google Al, and Operates Neymar Jr.'s Homecoming Flight

Lisbon, Portugal — November 11, 2025 —

bTd Travel & Jets, the global Al-powered concierge travel company, announced a new phase of expansion and innovation at **Web Summit Lisbon 2025**, revealing its entry into **Spain**, **Mexico** and the **GCC region** after completing its Seed-2 funding round and achieving record-breaking growth this year.

Following strong traction in the **U.S.**, **Brazil and Portugal**, bTd will begin operations in **Dubai and Abu Dhabi** this December, expanding to **Doha and Riyadh** by Q1 2026, in sync with **Web Summit Qatar**. This move secures bTd's **first-mover advantage** as the only travel-tech company in the region integrating **air**, **land**, **sea**, **and accommodations** into one platform — combining **Al automation** with **human concierge excellence** in multiple languages.

2025 Key Highlights & Milestones

Global Expansion

- Headquartered in the U.S., bTd officially entered Spain and Mexico in Q3 2025, strengthening its European and Latin American footprint after debuting in Portugal and Brazil in 2023.
- Launching in Dubai and Abu Dhabi (Dec 2025) through a local joint venture and expanding to Doha and Riyadh (Q1 2026) aligned with Web Summit Qatar.

Al Concierge Powered by Google Al

 Began new development of Al-driven personal travel agents in partnership with Google Al, capable of managing bookings, fare tracking for corporate travel,

- CO₂ offsetting, and traveler analytics enhancing user experience and cost optimization beyond App or web portal.
- Introduced a breakthrough "Empty Seat Upgrade Program", connecting business-class travelers with available private jet seats, bridging commercial and private aviation within the bTd members global ecosystem.

ESG & IMPACT Recognition

- Recognized as an IMPACT Startup at Web Summit Rio and Lisbon for its measurable sustainability results.
- Offset over 90 metric tons of CO₂ by optimizing 20 private jet empty legs, equivalent to 10 Lisbon–Miami charters, addressing aviation's 40% empty-flight inefficiency.

Financial & Operational Performance (YTD August 2025)

- Revenue +42% vs. 2024, reaching USD \$2.5M by August; projected to close 2025 at \$3.2M (+35% vs. plan) with solid margins.
- On track for breakeven by January 2026, completing a two-year turnaround after a \$1M R&D loss in 2023 during Seed-1.
- Portfolio: 9,000+ clients across

Landmark Jet Operations

In January 2025, bTd operated **Neymar Jr.'s homecoming flight** from Saudi Arabia to Brazil — one of the most tracked flights in history via Flight Radar.

The complex operation — involving **three jets and four helicopters** — showcased bTd's global logistics precision, discretion, and excellence in serving high-profile clients and ultra-HNW travelers.

Strategic B2B2C Partnerships

Expanded partnerships with XP Private Bank, JHSF ID Membership, Bradesco Visa Infinite, AMEX Centurion, Banco do Brasil Private, and C6 Bank/JP Morgan, offering integrated luxury travel benefits — from private jets to premium hotels, villas, sport cars and yachts — through white-label and co-branded programs.

Series A Preparation

After raising **USD \$2.2M** to date, bTd is preparing for **Series A in 2027**, targeting a **\$30M valuation**. Discussions are ongoing with **VCs, family offices, and institutional investors** across Europe, the U.S., and Qatar.
